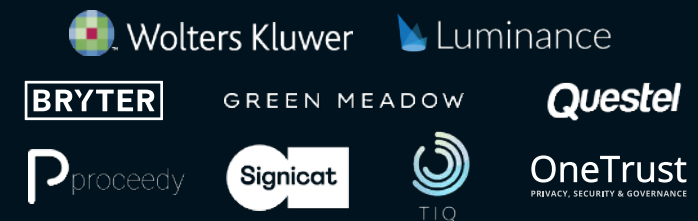

Based on the concept Smart Contracts, the presentation seeks to identify and discuss specific legal challenges that follows from the use of new technologies in relation to Smart Contracts. Existing and future regulation

of new technologies will be included. A proposition with regards to process and easily accessible tools will be introduced – in order to support the legal assessment and compliance with regulatory requirements when using new technologies such as Smart Contracts.
