## 12.10-12.40 - WHY AMMONIA NOW AND NOT ONLY IN THE FUTURE

Decarbonization of shipping is an enormous transformation of the whole industry where many major building blocks are needed. One of those is production and availability of clean fuels. In CIP we believe there will be several fuels in the future, but we believe that green ammonia will be the bigger one and we believe it can be developed at scale faster, cleaner, and cheaper than other clean fuels.

So, while we are waiting for 'the final touches' on engines and safety protocols it's time to get started with production planning and supply chain development, so we don't end up with more clean fuel capable vessels without access to clean fuels.
